NOTICE TO PROPERTY OWNERS

NOTICE IS HEREBY GIVEN: That there are now on file for public inspection in the Office of the City Clerk of Washington, Iowa, a proposed Resolution of Necessity, an estimate of cost and a plat & schedule showing the amounts proposed to be assessed against each lot and the valuation of each lot within a district approved by the City Council of Washington, Iowa, for a public improvement, described in general as the 2022 East Adams Street Improvements Project, of the type and in the location as follows:

Description of the Type and Location of the Improvement:

The paving of East Adams from South 9th Avenue to South 15th Avenue; the replacement or new installation of water main along the portion of East Adams from South 9th to South 15th; the installation of new storm water sewer main and drainage structures along East Adams; and the installation of sidewalk along East Adams; and related improvements.

The Council will meet in special session at 6:00 p.m. on January 25, 2022, at the Council Chambers, Washington Municipal Building, 215 East Washington Street, at which time and place the owners of property subject to assessment for the proposed improvement or any other person having an interest in the matter may appear and be heard for or against the making of the improvement, the boundaries of the district, the cost, the assessment against any lot, or the final adoption of the Resolution of Necessity. In lieu of physical attendance, property owners may attend by Zoom web conference by requesting a link and password from sallyhart@washingtioniowa.gov in advance of the meeting. A property owner will be deemed to have waived all objections pertaining to the regularity of the proceedings and the legality of using the special assessment procedure unless at the time of hearing he/she has filed objections with the Clerk.

**RESOLUTION OF NECESSITY FOR
2022 EAST ADAMS IMPROVEMENTS PROJECT**

WHEREAS, this Council has adopted a preliminary resolution pursuant to section 384.42 of the Iowa Code, as amended, covering the 2022 East Adams Improvements Project (hereinafter referred to as “the Project”); and

WHEREAS, in accordance with such preliminary resolution, the City Engineer has prepared preliminary plans and specifications, an estimated cost of the work, and a plat & schedule, including the valuation of each lot as determined by this Council, and the same have been duly adopted and filed with the City Clerk.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Washington, Iowa:

Section 1. That it is hereby found and determined to be necessary and for the best interest of the City and its inhabitants to proceed with the aforementioned Project, and to assess a portion of the cost thereof to the property benefited thereby.

Section 2. That the Project shall constitute a single improvement and shall consist generally of the paving of East Adams from South 9th Avenue to South 15th Avenue; the replacement or new installation of water main along the portion of East Adams from South 9th to South 15th; the installation of new storm water sewer main and drainage structures along East Adams; and the installation of sidewalk along East Adams; and related improvements in Washington, Iowa, all as more particularly described in the preliminary resolution relating to the Project previously adopted by this Council, which resolution is hereby referred to for a more complete description of the location and terminal points of the Project and the property benefited thereby and proposed to be assessed to pay a portion of the cost of such improvement. The location and terminal points of the Project are further described in the Notice to Property Owners as attached hereof.

Section 3. That it is hereby found and determined that there are on file in the office of the Clerk an estimated total cost of the proposed work and a preliminary plat and schedule showing the amount proposed to be assessed to each lot by reason of such Project.

Section 4. That this Council did meet on Tuesday, January 25, 2022 at 6 PM at the Council Chambers, Washington Municipal Building, 215 East Washington Street, at which time and place it heard the property owners subject to the proposed assessment or assessments and interested parties for or against the Project, its cost, the assessment thereof or the boundaries of the properties to be assessed.

Section 5. That the Clerk gave notice as required by Section 384.50 of the Code of Iowa, as amended, by publication once each week for two consecutive weeks in a newspaper published at least once weekly and having general circulation in the City, and likewise mailed a copy of such notice by Certified Mail to each property owner whose property is subject to assessment for the Project, as shown by the records in the office of the County Auditor, not less than 15 days prior to the hearing.

Section 6. That such notice was in form substantially the same form as attached Notice to Property Owners.

WHEREAS, Garden & Associates, Ltd., has prepared plans, specifications, form of contract and estimate of cost for the construction of certain public improvements described in general as the “2022 East Adams Street Improvement Project”; and

WHEREAS, preliminary plans and specifications have been drafted for the Project; and

**A RESOLUTION ENDORSING A DOWNTOWN INVESTMENT GRANT
AGREEMENT WITH DW DEVELOPMENTS**

WHEREAS, the City Council created the Downtown Investment Grants (DIG) program, in partnership with the Washington County Riverboat Foundation and Main Street Washington, to incentivize major building improvements in downtown Washington in accordance with Main Street guidelines; and

WHEREAS, as per the policies and procedures previously established by this Council, Main Street Washington has recommended a forgivable loan/grant be awarded to DW Developments to assist with an estimated \$500,000 investment in the building it owns at 111 North Marion Avenue (the Journal building).

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF WASHINGTON, IOWA:

Section 1. The City Council hereby approves the attached Downtown Investment Grant Agreement and Promissory Note, providing a forgivable loan/grant to DW Developments in the amount of \$25,000.

Section 2. Receipt of the grant is contingent on the receipt of the Iowa Economic Development Authority Downtown Housing Grant for this project.

Section 3. All Resolutions or parts of Resolutions in conflict herewith are hereby repealed to the extent of such conflict.
