


Purpose of Improvement Project




- **Contractor is required to notify property owner at least 24 hours in advance of planned disruptions**

 - **Will be closed from S. F Ave. to S. D Ave.**







I, Property Owner, as the owner of the property at *Address*, Washington, Iowa hereby consent that representatives from the City of Washington, Iowa, the City's consultant Engineer, the General Contractor, and his subcontractors may enter upon, have occupancy, and use of said private property for the purpose of making improvements. It is understood that this right of entry is granted under the following terms and conditions:

1. This right of entry shall be to enter upon private property for the purposes herein described for such period as is necessary to complete the work or until the project is completed.
2. Employees of the City of Washington, City's Consultant Engineer, the General Contractor and his subcontractors or representatives shall use every precaution to prevent damage to the land and facilities and shall repair any damage in the exercise of this right of entry.
3. The temporary entry will allow the Contractor to construct your private water service as generally shown on the attached typical water service installation exhibit attached. It is desired to extend your new private utility services to the existing curb stop, or approximately the property line as well as to allow directional drilling of the water main service under the street. All disturbed areas will be restored and seeded. In the event that the service falls within a gravel or paved driveway, the proposed surfacing within said area will be replaced to generally match the existing surfaces. Work may begin in approximately April of 2022 and be completed by December of 2022.
4. This right of entry, occupancy upon possible private property is granted without expectation of compensation or damages on our part.


