#### Rules & Regulations

The Chamber of Commerce has developed these rules and regulations to provide an enjoyable experience for all participants, spectators, and event staff. Failure to follow these rules may result in immediate removal from the flea market. We appreciate your cooperation in continuing to make this a fun and pleasant community event.

All booths will be assigned by the Chamber of Commerce, please let us know if you have a preference. You will be contacted with your assigned area by May 5th.

Exhibitors must supply their own racks, tables, chairs, and necessary displays.

Booth set up will begin one hour prior to start time.

Booths are to be set up and vehicles moved to reserved parking by 15 minutes prior to start time.

Booths to remain in operation from set hours below. Exhibits may not be removed until after show hours.

Collection and reporting of sales tax is the responsibility of each exhibitor. Sales tax in Washington is **7%**.

Due to limited parking, there will be a designated area assigned for your vehicles.

The Chamber of Commerce reserves the right to deny any application.

#### **2 different times will be set this year due to the different schedule for this year:**

**9 a.m.-3 p.m.** (Morning along sidewalk, in front of businesses)

**2-8 p.m.** (Afternoon in park, with other afternoon activities)

Registration is

**\$25 per booth space** for private vendors (Non-Chamber Member)

**\$5 per booth space** for non-profit's (Non-Chamber Member)

**FREE booth space** for Businesses with a Downtown Store Front, Chamber Members, info booths not selling items.

Booth fee and registration form must be received to reserve your booth space. Booth space will be assigned on a first come first serve basis. No refunds will be granted.
