The purpose of this field observation was to review construction progress made to date and answer construction related questions.

Exterior:

- 1. Phase 1 soffit on the west side of the building has been installed. A section of gutter and the downspout work is not finished.
- 2. The "POLICE | CITY HALL" signage has been installed above the main entrance.
- 3. The face brick veneer work appears to be completed.
- 4. The new metal roof at Phase 2 has been installed. Soffit, gutters, and downspout work remain.
- 5. Phase 1 soffit on the east side of the building has started. Most of the gutter has been installed. Downspout installation remains.
- 6. Mike indicated the glazing contractor has measured the exterior openings for fabrication.
- 7. The cast iron downspout boots have been delivered and are being stored west of the building.
- 8. Mike noted the replacement glass at Vestibule 131 and the glass in door (147) should be installed next week.
- 9. Contractors are pouring a section of the 7.5" concrete paving east of Phase 2 and west of the 3rd Avenue.
- 10. Keith noted the area around the utility transformer and generator should be changed from sod to a landscape rock and fabric. Kristofer agreed to produce a change document for this work.

Interior (Phase 2):

- 1. Contractors are installing insulation and gypsum board.
- 2. Hollow metal frames are being installed in the framed openings.
- 3. Electrical conduit and box rough-in work was observed.

- 4. HVAC rough-in work, including installation of the VRF units and associated piping, was observed.
- 5. Installation of copper and PVC waste/vent plumbing piping was in progress.
- 6. Fire sprinkler piping rough-in work, above the ceiling line, is in place.
- 7. Contractors are working on installation of the shower floor drain.
- 8. Mech/Electric [172]:
 - a. Electrical panels have been installed.
 - b. ERV-2 has been installed at bottom of roof structure.
 - c. BC-2 and VRF-02-01 have been installed.

Interior (Phase 1):

1. Keith Henkel and Kelsey Brown noted the veneer is chipping at the base of wood door (148). Kristofer noted the wood doors will be provided with a lifetime warranty which includes delamination of veneer if it is factory defect and not due to wear and tear.
