## *Department Activity Report August 2020*

We continue to see a steady increase in our calls for service with nearly 100 more calls for service in August of this year as compared to the same time last year. This includes increased cases of theft, vandalism, assault and drug offenses.

August started with a dangerous situation for one of our patrol officers, when attempting to make an arrest of a driver in a stolen vehicle; the driver fled the scene, dragging the officer for several blocks. The driver then abandoned that vehicle and stole another. Both vehicles were later recovered, but the driver remains at-large with multiple warrants. The officer had minor injuries and returned to duty after treatment at the hospital.

We provided extra patrol coverage for the Peace Proclamation event held in Central Park on August 10.

We received several messages, concerns and calls regarding sex offender residency and the activities of a group protesting.

### **Officer Training and Presentations:**

Officer Kephart and K-9 Dex participated in the Dogs for Law Enforcement training Aug 3-7 in Waterloo.

Officer Raymer provided training on less-lethal control devices to members of the department SWAT Team.

The Washington County Ambulance Service provided in-service training during our monthly staff meeting on the use of Narcan along with an orientation to their rigs and equipment.

## Water Treatment Plant: August/September 2020 Council Report

Here is a summary of major updates and activities from the Water Department in August/September 2020.

**Boil Order-**Will Brock had to issue a boil order at Timber Ridge/Oakwood area from Friday 9/4 1:00pm to Sunday morning at 10:00am. I was out of town. The boil order was a precautionary measure taken due to a water main break and losing pressure. Will did a great job of handling the situation. He contacted and communicated with all parties involved and followed the DNR's guidance. Will hung "Boil Order" hangers' door-to-door to all houses affected by the pressure loss. He took 3 bacteria samples on both Friday and Saturday and delivered them to our lab. As soon as the 2<sup>nd</sup> round of bacteria tests came back absent Sunday morning, he went door-to-door and posted "Boil Order Lifted" hangers. A huge shout out to Will, Tim, M&C, Brent, and all parties involved. That was about as smooth of a boil order as you can have.

**North 4<sup>th</sup> project-**The collapsed sewer has been repaired and we are no longer bypassing. We have had to periodically shut down for this project. The flashing lights on E 7<sup>th</sup> are being hooked back up. The west bound light is already up and working and the east bound light should be working this week.

**Traffic lights-** We lost power at the Wal Mart intersection on the day of the derecho storm. We put up stop signs. We witnessed a few near accidents. I called our traffic lights guy, Jim Conner and asked him to update our battery backup at that intersection. Traffic moves too fast at that intersection not to have it on battery backup. The battery backup was installed the following week. We had Joe Marie replace the bulbs at the underpass, 3 of the 4 were not working. We are planning for future traffic light upgrades.

**Water Plant Operations:** Submitted the July and August MORs. We have repaired some meters including at the hospital and the trailer park. Will read book 7. We collected routine monthly bacteria samples; results were absent. We changed bag filters and cleaned the filter vessels. Changed cartridge filters on RO 2. Our monthly bulk chemicals were filled up. Collected our monthly well levels. Submitted an updated Lead and Copper sampling plan and an updated groundwater bacteria sampling plan to the DNR at their request from our sanitary inspection. Low service pump 3 is not working. It is a few months past warranty but Harn is still going to honor the warranty and pay for repairs which will be about \$4,000. I have emailed Harn multiple times in the past 2 years with concerns about that pump being noisy and that is why Harn is covering the repairs.

**Operators:** We are still limiting ourselves from being in the public's homes and having people at the plant. We are only going in homes as needed and letting people in the plant as needed. We attended an online class by the DNR. I will be attending a water/wastewater conference in Okoboji the last week of the month. I attended weekly staff meetings. I attended a wellness park meeting. Both Will and I plan to take exams as soon as the DNR opens back up testing. Stay safe everyone!

## **Frequently Asked Questions About Racism**

Materials prepared by Washington For Justice for 9/15/2020 Washington City Council meeting

All italicized quotations are from How To Be an Antiracist, by Dr. Ibram X. Kendi.

### **What is racism?**

*"Racism is a marriage of racist policies and racist ideas that produces and normalizes racial inequities."*

*"A racist idea is any idea that suggests one racial group is inferior or superior to another racial group in any way. Racist ideas argue that the inferiorities and superiorities of racial groups explain racial inequities in society."*

*"An anti-racist idea is any idea that suggests the racial groups are equals in all their apparent differences - that there is nothing right or wrong with any racial group. Anti-racist ideas argue that racist policies are the cause of racial inequities."*

Racism occurs when a person or group makes a snap judgement about another person or group based on their skin color, then uses their power (implicit or explicit) to enact discriminatory policies and/or influence cultural norms.

### **Why is racism harmful to our community?**

Treating our neighbors differently because of their skin color fosters a sense of "otherness" that creates distrust and conflict. Racism divides, rather than unites. It discourages collaboration, which in turn limits growth of character and economic opportunities. Being perceived as a racist community restricts the flow of new individuals who might otherwise consider moving to Washington. Additionally, racism in our community hinders the ability for all residents to be represented, as their voices are not equally heard and considered by those in positions of leadership.

### **Are my words and/or actions racist?**

*"The most threatening racist movement is not the alt right's unlikely drive for a White ethnostate but the regular American's drive for a 'race-neutral' one."*

Actions and words that make broad generalizations about a person or group based on their skin color are racist. They undermine each individual's character, often superimposing a negative stereotype that inhibits personal interaction or relationship-building.

### **How can I be anti-racist?**

*"Like fighting an addiction, being an antiracist requires persistent self-awareness, constant self-criticism, and regular self-examination."*

We are not, and will never be, colorblind when it comes to skin color. Striving for a "post-racial" society ignores the cultural and socio-economic differences present in our community. Instead, we must increase awareness of our inclination for stereotypes, question our long-held beliefs about people who are different from us, and actively work to make our community a place where all people feel welcome and have access to equitable opportunities. There is no category for "not racist"; every policy and action is either "racist" or "anti-racist."

We received more than 300 signatures, including 122 signatures from current residents of Washington and 103 signatures from elsewhere in Iowa. Many of the signatures are from current and former Washington residents – people who care deeply about our community. As a point of comparison, Council Member Gault received 161 votes and Council Member Stigers received 144 votes in the 2017 city election.

While we are not able to force you to take any actions, we do hope you will remember that the public has heard your words, seen your actions, and will remember that at the voting booth when your terms are up. There are several members of our diverse community who are willing to run for city council in an effort to diversify the faces of leadership in Washington, as well as ensure all members of this community are represented. In the meantime, Washington for Justice will shift its focus to a proposal for an anti-racist committee to aid in the mission of working toward the ultimate goal of anti-racist local leaders and an anti-racist community.

### **IDEA Committee Proposal**

Washington For Justice will submit a proposal to the City Council for the formation of an Inclusion, Diversity, Equity, and Accountability (IDEA) Committee. This IDEA Committee would work with the City Council and other local governmental officials to ensure fair treatment, equality of opportunity, and fairness in access to community resources in Washington. The IDEA Committee would also organize educational events and serve as a resource for marginalized members of our community. We are requesting to be on the agenda for the October 6th city council meeting to formally present this proposal.



Memo: Hydrogen Sulfide Mitigation

As most of you are aware, we have been dealing with a rotten egg smell at the water plant since we went online with the new plant in 2018. The rotten egg smell is hydrogen sulfide gas from our raw drinking water. The smell is coming from our aerator which is on top of the new building at the water plant. Our options to mitigate the smell are well treatments or raising the aerator stack exhaust. Shock chlorinating the wells is much more expensive.

We had Evans Welding raise the aerator stack last year. We noticed the odor was not as bad but unfortunately, we can still smell the hydrogen sulfide. We would like to raise the stack another 10' and put a T at the bottom of the stack. The T at the bottom of the stack would allow outside air to mix with and dilute with the hydrogen sulfide gas. We believe this is the most economical way to mitigate the odor and would like council's approval to move forward. If you have any questions please call or email.

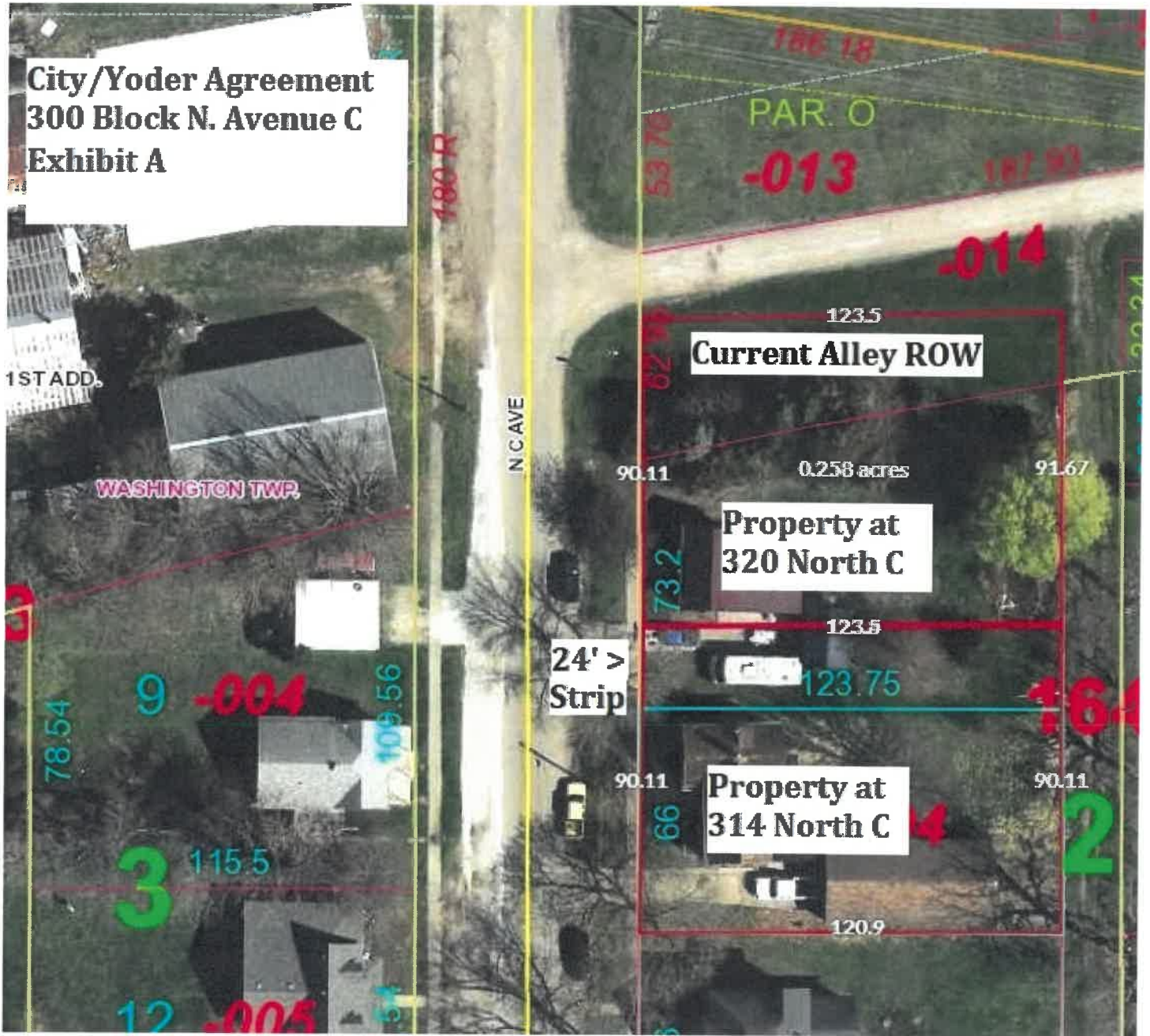

Re: Demo of 314 & 320 North C; Construction of Duplexes

As Council is aware, the City recently acquired the fire-damaged house at 320 North C. There is another fire-damaged house next door to it at 314 North C, which is owned by Enos Yoder. I believe it makes sense to work with Mr. Yoder on getting both houses demolished, and it is possible to turn this into a deal for Yoder to construct 2 new duplexes in place of these 2 houses, with a small amount of survey work to utilize unused alley right-of-way to add to the lot at 320 North C, and by transferring a 24' strip of property to Yoder to create a 90' frontage lot at 314 North C. See the attached exhibit for details.

In order to accomplish this, Council would need to set a hearing on a development agreement with Yoder and also bid out the demolition work. The hearing and action on both items would be at the October 6 City Council meeting.

### **DEVELOPMENT AGREEMENT**

This Agreement is made this \_\_\_\_\_ day of \_\_\_\_\_, 2020, between the City of Washington, Iowa, 215 East Washington Street, Washington, Iowa, hereafter the “City”; and Enos R. Yoder, a single person, 2293 Johnson-Washington Road, Kalona, Iowa, hereafter “Yoder”.

WHEREAS, Yoder is the owner of that certain lot legally described as follows:

Lot 11, Block 2 of M.M. Young’s Addition to the City of Washington, Washington County, Iowa, known locally as 314 North Avenue C (the “Property at 314 North C”)

; and

Whereas, City is the owner of that certain lot adjacent to the Property at 314 North C, legally described as follows:

Lot 7, Block 2 of M.M. Young’s Addition to the City of Washington, Washington County, Iowa, known locally as 320 North Avenue C (the “Property at 320 North C”)

WHEREAS, Yoder wishes to redevelop the Property at 314 North C for two-family duplex residential purposes (the “Project at 314 North C”); and have an option to redevelop the Property at 320 North C in a similar manner (the “Project at 320 North C”); and

WHEREAS, each property is located within the Washington Urban Revitalization Area; and

WHEREAS, it is in the best interest of the City for each Property to be redeveloped.

NOW, THEREFORE, ON THE BASIS OF THE PRECEDING RECITALS, AND FOR THE MUTUAL CONSIDERATION OF ENTERING INTO THIS AGREEMENT, THE DEVELOPER AND CITY AGREE AS FOLLOWS:

**A. City's Obligations.**

1. City agrees to demolish the existing houses including removal of the existing foundations and disconnection of private utilities at the Property at 314 North C and the Property at 320 North C, at its sole expense, no later than December 31, 2020.

2. City agrees to arrange & pay for the plat of survey of 314 North C, 320 North C, and the east-west alley north of 320 North C, as shown in Exhibit A to this Agreement, with the goal of creating a 24' x 123.75' strip (the "24' strip") for transfer to Yoder upon performance of certain obligations as stated in this Agreement, reconstituting the Development Property as an approximately 90'(street frontage) x 123.75' (depth) lot.

3. City shall, upon appropriate application by Yoder, grant tax abatements to Yoder in accordance with the Washington Urban Revitalization Plan.

4. Upon Yoder's completion of the Project at 314 North C as agreed upon, the City establishes intent to grant Yoder an option to purchase 320 North C for \$1, in exchange for Yoder's agreement to construct two-family duplex housing on the property within eighteen (18) months of completion of the Project at 314 North C. Said option shall be adopted by separate agreement upon completion of the Project at 314 North C.

5. City will record the survey and deeds referenced above and will assume all recording costs.

**B. Yoder's Obligations.**

1. Yoder agrees to provide City staff with access as needed to the Property at 314 North C and to cooperate with the demolition process.

2. Yoder agrees to construct the Project at 314 North C within thirty (30) months of City Council approval of this Agreement. City shall transfer the above-referenced 24' strip within sixty (60) days of a valid building permit application, readiness to proceed, and

affirmative statement by Yoder to meet all minimum standards specified in this Agreement. In addition to the adopted codes of the City of Washington, said minimum standards are as follows:

- a. Stick-built or approved modular construction
- b. Poured concrete foundation/slab
- c. 900 square feet of living area
- d. One-car attached garage
- e. Paved driveway at garage width from garage to property line

In the event that Yoder fails to complete the Project at 314 North C within said 30-month time period, Yoder shall reimburse the City for the entire cost of demolition of the existing house at the 314 North C Property within thirty (30) days of invoice by the City. Yoder expressly agrees that in the event that Yoder fails to reimburse the City for said demolition costs, that the City has the right to file the costs of demolition with the Washington County Treasurer to be collected in the same manner as property taxes.

3. Within thirty (30) days of issuance of a Certificate of Occupancy by the City Building Official for the Project at 314 North C, Yoder shall notify the City of his desire to proceed with an option agreement for purchase the City property to construct the Project at 320 North C. If Yoder does not notify the City within this 30-day time period, Yoder's right to purchase the 320 North C Property pursuant to the terms of this Agreement shall become null and void and City may contract to sell the property to a different party or propose to enter into a new agreement with Yoder, at its sole discretion.

4. If Yoder exercises said option, he shall complete construction on the Project at 320 North C within eighteen (18) months of the completion of the Project at 314 North C. The Project at 320 North C shall meet the same minimum standards as the Project at 314 North C, as described above. Yoder expressly agrees that the quit claim deed to convey the 320 North C Property to Yoder will contain a right of reverter in the City if Yoder fails to complete the Project at 320 North C within said 18-month time period.

5. Yoder will cause all Projects under this Agreement to be constructed on each Property in strict compliance with the all applicable laws, regulations and ordinances.

### **C. Administrative Provisions.**

1. Each party represents to the other that the party has full power and authority to enter into this Agreement and that this Agreement is a binding Agreement duly authorized by the governing body of each party.

2. This Agreement represents the entire agreement between the parties and may not be amended or assigned without the express permission of the other party.

3. This Agreement shall inure to the benefit of and be binding upon the successors and assigns of the parties.

4. This Agreement shall be deemed to be a contract made under the laws of the State of Iowa, and for all purposes shall be governed by and construed in accordance with the laws of the State of Iowa.

5. If any provision of this Agreement or the application thereof to any person or circumstance shall be invalid, illegal or unenforceable to any extent, the remainder of this Agreement and the application thereof shall not be affected and shall be enforceable to the fullest extent permitted by law.

6. That this Agreement may be executed in counterparts.

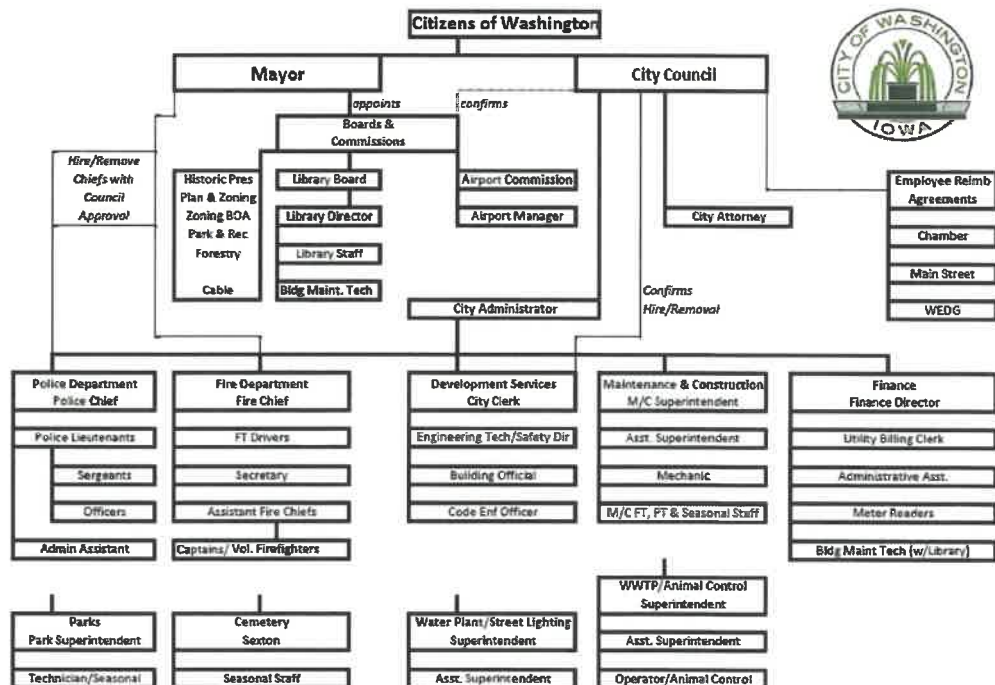
## The Department & Organization

The City of Washington provides efficient, cost-effective, quality public services to the residents of the Washington community, including but not limited to Police, Fire, Animal Control, Library, Parks, Cemetery, Street Maintenance, Water, and Wastewater. The City contracts for various services including recreation programming, aquatic center operations, and residential solid waste & recycling services.

The City's FY21 all-funds budget is \$20.7 million, including \$8.7 million in capital investment. The City has a moderate general obligation debt load, and has maintained an A+ bond rating from S&P over the last several years. City finances are solid and stable, with a general fund balance of \$1 million, as compared to annual general fund expenditures of about \$3.8 million, and total fund balances not including bond proceeds of around \$6 million. The City enjoys a stable and committed workforce, with average turnover of 3-4 positions annually, as compared to 49 total full-time employees.

The City Clerk has been a "one-person department" in recent years. The City of Washington is completing facility improvements to the Municipal Building following a long and exhaustive facility planning process. A new 14,918 square foot Fire Station was added to the existing 9,403 square foot Municipal Building in 2018-2019, and construction began on the existing building for City Hall/Police Department following the Fire Department's move to their new space. Re: Stop Signs in Wellness Park Area

Due to the Wellness Park development and paving that will start very soon, it is time to consider putting a stop signs on North D at the West 7<sup>th</sup> intersection and then on North E and West 7<sup>th</sup> at their intersection. Making this latter ordinance change will actually create a four-way stop, as Iowa Code 321.321 specifies that traffic from driveways, etc. must stop at entrances to public roads. **WHEREAS**, the General Assembly of the State of Iowa has taken measures to allow the sale and use of consumer fireworks in the State of Iowa during specific timeframes and pursuant to applicable state licensure; and

**WHEREAS**, the legislation provides for city councils, by ordinance, to prohibit or limit the use of consumer fireworks within their jurisdiction, if determined a public safety risk or a nuisance to neighbors; and

**WHEREAS**, the Council has determined that the discharging of consumer fireworks under the law is a public safety risk and a nuisance to neighbors.

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council of Washington, Iowa as follows:

**SECTION 1. REPEAL SECTIONS.** Chapter 41.14(3A) through (3I) related to Fireworks- Discharging General Requirements are hereby repealed.

**SECTION 2. ADOPT NEW SECTION & RENUMBER.** A new Chapter 41.14(3A) is adopted as follows, and all subsequent items are renumbered:

“3A. The use or explosion of consumer fireworks within the City is hereby prohibited.”

**SECTION 3. REPEALER.** All ordinances or parts thereof in conflict with the provisions of this ordinance are hereby repealed.

Re: Mayor and Council Pay

It has been brought up that we may want to review Mayor and Council pay. This was last changed in 2003. Iowa Code is very specific about how a process to adjust the pay works and when it is effective. I have attached Iowa Code 372.13(8) for your information, but the basics are that any changes in pay must be adopted by ordinance prior to November 1 in a regular city election year (which is not until 2021), and the pay increase is not effective for Council until the January 1 following that election, and not for the Mayor until the start of his/her next term. Therefore, any changes would be effective for the Mayor and the whole Council (not just newly elected members) on January 1, 2022.

I have also attached the last ordinance done on this topic from 2003.

By ordinance, the council shall prescribe the compensation of the mayor, council members, and other elected city officers, but a change in the compensation of the mayor does not become effective during the term in which the change is adopted, and the council shall not adopt an ordinance changing the compensation of the mayor, council members, or other elected officers during the months of November and December in the year of a regular city election. A change in the compensation of council members becomes effective for all council members at the beginning of the term of the council members elected at the election next following the change in compensation. Except as provided in [section 362.5](#), an elected city officer is not entitled to receive any other compensation for any other city office or city employment during that officer's tenure in office, but may be reimbursed for actual expenses incurred. However, if the mayor pro tem performs the duties of the mayor during the mayor's absence or disability for a continuous period of fifteen days or more, the mayor pro tem may be paid for that period the compensation determined by the council, based upon the mayor pro tem's performance of the mayor's duties and upon the compensation of the mayor.

9. A council member, during the term for which that member is elected, is not eligible for appointment to any city office if the office has been created or the compensation of the office has been increased during the term for which that member is elected. A person who resigns from an elective office is not eligible for appointment to the same office during the time for which that person was elected if during that time, the compensation of the office has been increased.

10. A council member, during the term for which that member is elected, is not precluded from holding the office of chief of the volunteer fire department or from serving the volunteer fire department in any other position or capacity. A person holding the office of chief of such a volunteer fire department at the time of the person's election to the city council may continue to hold the office of chief of the fire department during the city council term for which that person was elected.

11. a. Council members shall be elected according to the council representation plans under [sections 372.4](#) and [372.5](#). However, the council representation plan may be changed, by petition and election, to one of those described in [this subsection](#). Upon receipt of a petition meeting the requirements of [section 362.4](#), requesting a change to a council representation plan, the council shall submit the question at a special election. If a majority of the persons voting at the special election approves the changed plan, it becomes effective at the beginning of the term following the next regular city election. If a majority does not approve the changed plan, the council shall not submit another proposal to change a plan to the voters within the next two years.

b. Eligible electors of a city may petition for one of the following council representation plans:

- (1) Election at large without ward residence requirements for the members.
- (2) Election at large but with equal-population ward residence requirements for the members.

(3) Election from single-member, equal-population wards, in which the electors of each ward shall elect one member who must reside in that ward.

(4) Election of a specified number of members at large and a specified number of members from single-member, equal-population wards.

**AN ORDINANCE AMENDING SECTION 15.04 CONCERNING MAYORAL

**BE IT ORDAINED** by the City Council of the City of Washington, Iowa:

**SECTION 1.** The Code of Ordinances of the City of Washington, Iowa, 2003, is hereby amended by revising Section 15.04, titled "Compensation", of the Washington City Code of Ordinances to read as follows:

**15.04 COMPENSATION.** The salary of the Mayor is twelve thousand dollars (\$12,000 per year).

**SECTION 2.** The Code of Ordinances of the City of Washington, Iowa, 2003, is hereby amended by revising Section 17.06, titled "Compensation", of the Washington City Code of Ordinances, to read as follows:

**17.06 COMPENSATION.** The salary of each City Council member is fifty dollars (\$50.00) for each meeting of the Council attended, payable semiannually.

**SECTION 3. REPEALER.** All ordinances or parts of ordinances in conflict with the provisions of the ordinance are hereby repealed.

**SECTION 4. SEVERABILITY CLAUSE.** If any section, provision or part of this ordinance shall be adjudged invalid or unconstitutional such adjudication shall not affect the validity of the ordinance as a whole or any section, provision or part thereof not adjudged invalid or unconstitutional.

**SECTION 5. WHEN EFFECTIVE.** This ordinance shall be in effect from and after its final passage, approval and publication as provided by law.
