### Major Accomplishments in 2023

Purchased & acquired new SCBAs.

- 27 new SCBAs
- Purchase price of \$220,000
- Received and put into service in May of 2023
- Applied and received a FEMA AFG grant for \$183,000
- Designed and ordered a new 2025 Toyne Custom Pumper Truck
  - Requested approval in July of 2023
  - Expected delivery fall of 2025
  - Applied and secured \$250,000 grant from WCRF
- Designed and ordered a new 2024 Foam Commander foam trailer
  - Requested approval in October 2023
  - Expected delivery May of 2024
  - Approved railroad funding

Designed, secured funding, and started building expansion project to house our equipment on site

Secured funding and purchased a new Ram 2500 support pickup

Interviewed, and appointed a new Asst Chief of EMS after Carrie Ornduff's resignation

Welcomed 3 new members to our service


### New frontline Engine 1

- Seats 6 people


### New Foam Commander foam suppression trailer

- Partnered with IRE for foam supply




### 2023 CALL TYPES – FIRE ONLY




### 2023 CALL TYPES BY MONTH – FIRE ONLY




### 2023 CALL TYPES BY MONTH – EMS ONLY

# WAFD Training

- Training Officer Doug Sanders
- 1,141 combined training hours in 2023
- Meetings on the first Wednesday of every month
- Training on the 3<sup>rd</sup> Wednesday of every month
- Special trainings on weekends occasionally
- 24 hours of continuing education per year
- Attend 2 out of the 3 mandatory drills per year
- Attend 1 out of every 3 regularly scheduled meetings
- Take and pass the Firefighter 1 & Hazmat ops class within 24 months of becoming a member.
  - ▶ FF1 & Hazmat class is 105 hours.
