Motion by Isabella, seconded by Diane, to approve the agenda as presented and the April 26, 2022, minutes. Motion approved.

Millie handed out a spreadsheet tracking expenditures for FY2021-22. The form also showed tax collections by fiscal year and funds committed for projects as of 04/20/2022. As of May 23<sup>rd</sup> we have a balance of \$117,443.47 in the Hotel/Motel Fund.

Deanna, Millie, Isabella and Michelle gave recaps of the conferences they had attended. Deanna got some good tips. Millie and Isabella's group was smaller so they got to get acquainted better. Michelle good brainstorming event on tourism.

Clay had sent out updated signage examples and the Committee will work on details next meeting. We did not get the AARP grant but we could resubmit for it.

Discussion on Destination Iowa grant and what it requires. Discussion on possible local attractions to use when submitting for grants.

The YMCA wants to keep the old Y to use the pool until the new pool is built.

The City of Washington is paying for the hotel feasibility study so that the study can get going as soon as possible. Motion by Diane, seconded by Isabella, that Hotel/Motel Committee pay half of the cost of the study. Motion approved unanimously.

Michelle is waiting to see how to get listed on the Meet in Iowa Grant.

**Film Festival** update from the committee which meets every Tuesday. They are closer to a budget. Dates for the Film Festival have been set for May 20-21, 2023. The committee are working on selecting a logo and a name for the Film Festival.

Some of the quilt blocks will be on display during the Summer Classic. The quilts will be installed for mini walking tours around the Square, Halcyon House, UP Home, and Kewash/Sunset Park. Shirts are available for sale at the Chamber Office. Quilt making classes are planned. Discussion on possible income projects with sale of the quilt blocks, and use of tile and bricks from the Captain's Table.
