Financial Report - the current balance is \$158, 082.66

Public Presentation – Pragnesh Patel from the Hawkeye Motel gave an update about his business. The hotel in Columbus Junction seems to be their greatest competition. They have 22 rooms, bookable online and recently renovated and repainted and offer both daily and weekly rates. They have thought about adding an entrance directly from the highway to allow trucks to pull in. People are coming in for funerals and employee trainings. There is 1 room for a travel nurse that comes and stays on a monthly term.

Suggestion: arrange for joint advertising with all overnight accommodations in Washington, ask what is bringing their guests to Washington.
